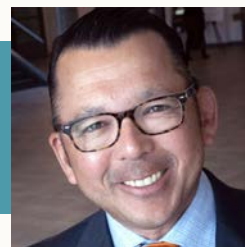

CHILDREN & YOUTH

EAC Network's Children & Youth services work intensively with children who are victims of child abuse and neglect, or involved in the foster care system. Our team of experts provide supervised visitation between noncustodial parents and their children, promote child passenger safety, offer mentors for at-risk youth, and a myriad of additional services that help children and youth to live free from fear, safe from violence, and protected from abuse and exploitation.

As an adopted child with some mental health challenges, J.B. is physically aggressive and has difficulty communicating his needs. When J.B. first entered the Chance to Advance program, he was highly resistant and did not speak during my first home visit to explain the program. He eventually expressed the desire to get out of his house, do more activities, and make friends. The first recreational activity he attended was at Dave and Busters. Since attending the first activity, he has attended almost every positive youth development activity as well as the EAC Boys Support Group. In addition, he participated in the Shop with a Cop and the Bethpage Federal Credit Union Youth Holiday Shopping Spree events. His behaviors are no longer destructive, and he is attempting to communicate his thoughts without harming others more effectively. J.B. was also recently matched with a mentor. Due to his mentor's ability to communicate with J.B. on his level, it has been a life-changing experience for him. He has always wanted to be a part of something, engage in new activities, and meet new people, and he has achieved this goal in a such a short timeframe. Chance to Advance has already had a huge impact on J.B. according to his guardian.

VOCATIONAL

EAC Network offers a variety of vocational programs and supportive services that provide the necessary skills for obtaining and retaining employment, particularly with homeless and at-risk populations, and those challenged with substance use disorder. The HempsteadWorks Career Center offers resources and training to prepare eligible residents in the Town of Hempstead and the City of Long Beach for competitive job placements and careers with growth potential. Mission Employment assists out-of-school or at-risk youth, ages 18-24, who reside in the Town of Hempstead or City of Long Beach towards a career path.

Mr. N was referred to EAC's Brooklyn TASC program due to violating Penal Code 140.25, Burglary in the 2nd Degree. He was assessed and found eligible for TASC services with the recommendation of long-term residential treatment followed by aftercare services at an outpatient treatment program. TASC referred Mr. N to Odyssey House for residential treatment and a favorable court update was submitted for the entirety of his residence in treatment. Upon completion at Odyssey House, Mr. N was then referred to Bridge Back to Life for aftercare services. Since admission at Bridge Back to Life, he has done well in treatment, is in full compliance, and has tested negative for all illicit substances. He is also in compliance with TASC's weekly toxicology appointments. Throughout his mandate, Mr. N maintained sobriety and completed the program without any incident, resulting in dismissal of his felony charge.



BEHAVIORAL HEALTH & CRIMINAL JUSTICE

EAC Network's Behavioral Health & Criminal Justice programs work in tandem with the criminal justice system to help individuals suffering from mental health and/or substance use disorders to obtain treatment that leads to a better life. Through our TASC (Treatment Alternatives for Safer Communities) and CRAN (Community Reentry Assistance Network) Programs, an emphasis on equality and fairness leads to a sustained impact that can be measured by strengthened communities, reduction of crime, enhanced public safety, health and healing, and individuals being productive members of the workforce and their community.

Furthermore, EAC is nationally and internationally recognized for assessment and coordinating services for those involved with the criminal justice system. The Council of State Governments (CSG) Justice Center designated EAC Network's Mental Health Diversion program as one of four jurisdictions that were appointed Mental Health Collaboration "Learning Sites."

“Jane” and her husband “John” started working with EAC’s Long Island Parenting Institute (LIPI) in October of 2022 when their one-year-old son was placed into foster care. They successfully completed the program and used the tools learned in their visits with their son. One year later, they returned to the program due to a newborn baby girl. At this time, Jane had regained custody of her children. However, John had not. Jane was feeling isolated and overwhelmed with a newborn and a now two-year-old. Jane and John, despite not being able to live together, attended every class LIPI had to offer. In addition to the classes, LIPI was able to provide the family with real-time support throughout the week to help mom and the kids transition to being together again. Jane and John continue to be in touch with the LIPI Program Director for support and services.



SENIORS & NUTRITION

EAC Network is the largest provider of Meals on Wheels in Nassau County. We act as guardians for seniors, as well as mentally and/or physically incapacitated individuals, who are unable to manage aspects of daily life on their own. Our four Senior Centers provide warm meals, exercise, and social interaction to local seniors. We also have trained companions to provide caregivers with in-home respite.

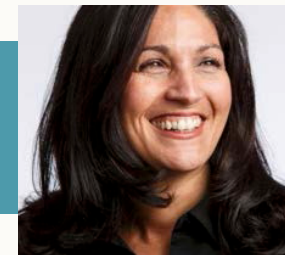

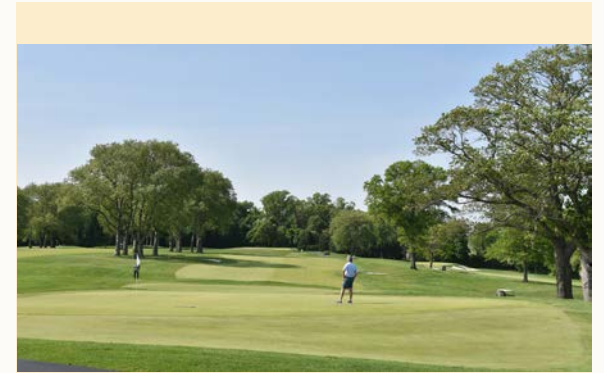
Petals of a Power Mom with Tamara Walcott

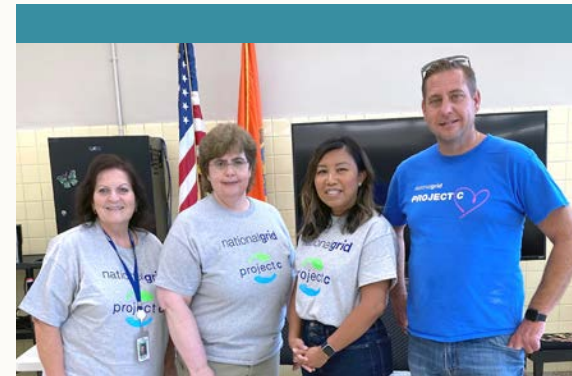

As part of National Grid's Project C, National Grid volunteers supported EAC in numerous ways:

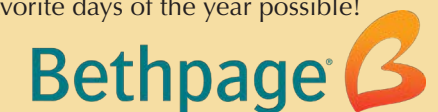


